

## **“The Dark Knight Rises” Sweepstakes Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. “The Dark Knight Rises sweepstakes” (“Sweepstakes”) will begin at 1:00am Eastern Standard Time (“EST”) on July 28<sup>th</sup>, 2012 and end at 5:59pm EST on August 11<sup>th</sup>, 2012 (“Sweepstakes Period”). Sweepstakes is sponsored by Gameloft Inc. (“Sponsor”).

Each entrant may submit only one entry during the Sweepstakes Period.
