

“Green Farm Samsung Galaxy Tab” Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. “Green Farm Samsung Galaxy Tab sweepstakes” (“Sweepstakes”) will begin at 00:00am Eastern Standard Time (“EST”) on November 25, 2010 and end at 23:59pm EST on November 25, 2010 (“Sweepstakes Period”). Sweepstakes is sponsored by Gameloft Inc. (“Sponsor”).

To Enter:

1) Play at Green Farm on Facebook.com at <http://www.facebook.com/greenfarm>. If you do not have an account on Facebook, you must create one by following instructions on Facebook.com. Creating an account is free. Once logged in, go to <http://www.facebook.com/greenfarm>, and click on the button “Go to Application” and follow instructions until you play the game. Each entrant may submit only one entry during the Sweepstakes Period. Any attempt by any person to enter more than one entry by using multiple/different email addresses, identities, registrations, or any other methods will void all entries entered by that person and that person, at the sole discretion of Sponsor, may be disqualified from the Sweepstakes. Upon initial notification and verification of potential Grand Prize winner, confirmation will be sent to the winner in writing via e-mail.
